SCHOOL TRANSPORT CONTRACT

GATHERED

On the one hand, Autocares Mi-Sol S.L. with Tax ID Number B53681961 and registered address at C/ Juan de Herrera 15, 03203 Elche, represented by Santiago Miralles Antón, holding National ID No. 21982424J, hereinafter referred to as "the Company",

DECLARE

The Company enters into this contract with each family of the students of the European School of Alicante (EEA) who wish to use the school transport service.

Both the Company and the signing family acknowledge the supporting role played by AMPA in the organisation and management of the service. However, AMPA does not assume any responsibility for the provision of this service, as it is not a party to the contractual relationship established between the Company and the families.

Both parties have agreed to enter into this contract, under the following:

TERMS

1. PURPOSE OF THE CONTRACT

The Company undertakes to provide the school transport service to the Customer for the transportation of the student(s) between the designated the bus stops on each route and the EEA, in accordance with the conditions set forth in the Collaboration Agreement signed between the Company and AMPA, hereinafter "the Agreement"¹, which is available on the AMPA website under the "Transport" section and of which the parties expressly acknowledge awareness.

The Client shall complete the registration form available under the “Transport” section of the AMPA website at the beginning of each school year.

2. ENTRY INTO FORCE AND DURATION

The school transport service will be provided throughout the 2025-2026 school year and may be tacitly renewed each subsequent school year under the same conditions as the original agreement.

3. COST AND BILLING OF THE SERVICE

The service will be provided by the Company, at its own cost and risk, for a fee, in accordance with the prices published in the transport section of the AMPA website. These prices will be collected by direct debit, in ten (10) monthly instalments (from September to June).

Prices shall remain fixed during the term of the contract and may be revised with a minimum notice period of three (3) months prior to contract renewal, following consultation and agreement between the parties designated by AMPA and the Company.

AMPA members will receive a 3.5% discount on the prices set by the company.

The monthly prices for the 2025/2026 academic year will be as follows:

**On routes 3 and 4, the lowest fares apply to stops within the city of Alicante or at the EUIPO, while the highest fares apply to stops outside the urban area of Alicante.

Transport on Wednesday afternoons at 4:15 p.m. from the European School to EUIPO is not included in the regular price. This service can only be provided if at least 15 users register. An additional fee will apply, which varies depending on the total number of participants, as follows:

4. PERFORMANCE OF THE SERVICE

In addition to complying with the obligations set forth in this contract and those inherent to the provision of the transport service, the Company undertakes to perform the service in accordance with the provisions of the Agreement, particularly with regard to the clauses relating to the vehicles and personnel assigned to the service, the necessary authorisations and licences, and the procurement of the corresponding insurance policy. The company assumes full responsibility for complying with all obligations imposed by Royal Decree 443/2001, of 27 April, concerning safety conditions in school and minor transport, and any applicable legislation.

5. CONDUCT ON TRANSPORT

Students using the transport service must comply with the established timetable and rules of conduct, both of which are published under the "Transport" section of the AMPA website.

6. TERMINATION OF THE CONTRACT

The contract may be terminated in the following cases:

- By unilateral decision of the Customer, with at least 10 days' notice prior to the last day of the month.
- Due to breach of the rules of conduct on transport by the user/student, after prior warning.
- By mutual Agreement of the parties.

7.- DATA PROTECTION AND CONFIDENTIALITY

The Company undertakes to comply with the provisions of Regulation (EU) 2016/679 of 27 April (General Data Protection Regulation - GDPR) and Organic Law 3/2018, of 5 December, on the Protection of Personal Data and Guarantee of Digital Rights (LOPDGDD), as well as any other regulations in force regarding data protection.

The Customer undertakes to sign the consent form for the processing of their data provided by the Company.

8. DISPUTE RESOLUTION

Any dispute regarding the interpretation or application of the contract shall be governed by Spanish law and shall be resolved by the courts of Alicante.
